CITY OF DEL RIO FY 2022-2023 Annual Hotel Occupancy Tax (HOT) Funds

By ordinance, the City of Del Rio approves a local hotel occupancy tax with portions of the fund to be dedicated to support convention and tourism centers, promotional and tourist advertising of the City, promotion of the arts, historical preservation and program support for events and activities that attract tourists to the City of Del Rio.

I. Use of HOT Funds

Municipal hotel occupancy taxes are primarily governed by Chapter 351 of the Texas Tax Code. The HOT funds are generated as a result of a person paying for the use or possession, or for the right to the use or possession, of a room in a hotel, motel or bed and breakfast, with a cost of \$2 or more each day, that is ordinarily used for sleeping, not on a permanent basis.

There is a **two-part test** for every expenditure of local Hotel Occupancy Taxes.

Criteria # 1 Every expenditure must DIRECTLY enhance and promote tourism AND the convention and hotel industry.

"Tourism" is defined under Texas law as guiding or managing individuals who are traveling to a different, city, county, state or country. A "direct" promotion of the convention and hotel industry has been consistently interpreted by the Texas Attorney General as a program, event, or facility likely to cause increased hotel or convention activity. This activity may result from hotel or convention guests that are already in town and choose to attend the hotel tax funded facility or arts or historical event, or it may result from individuals who come from another city or county to stay in an area lodging property at least in part to attend the hotel tax funded event or facility.

Criteria # 2 Every expenditure of the hotel occupancy tax MUST clearly fit into one of nine statutorily provided categories for expenditure of local occupancy tax revenues.

The nine categories for expenditure of the hotel occupancy tax are as follows:

- 1. Funding the establishment, improvement or maintenance of a convention center or visitor information center.
- 2. Paying the administrative costs for facilitating convention registration.
- 3. Paying for advertising, solicitations, and promotions that attract tourists and convention delegates to the city or its vicinity. (1/7 of total funds must be spent on advertising and promoting the city and its vicinity to attract tourist and hotel/convention activity)
- 4. Expenditures that promote the arts, including instrumental and vocal music, dance, drama, folk art, creative writing, architecture, design and allied fields,

painting, sculpture, photography, graphic and craft arts, motion pictures, radio, television, tape and sound recording, and other arts related to the presentation, performance, execution and exhibition of these major art forms. Texas law requires that the arts related expenditure also directly promote tourism and the hotel and convention industry.

- 5. Funding historical restoration or preservation programs. This funding may be used in primarily two ways. First, to enhance historical restoration and preservation projects. Second, for activities or advertising and conducting solicitations and promotional programs to encourage tourists and convention delegates to visit preserved historic sites or museums. Either of those uses must be for activities, programs or events that are likely to attract tourists and hotel guests.
- 6. Funding certain expenses, including promotional expenses, directly related to a sporting event within counties with a population of under 1 million. This sporting event must include mostly participants from out of town.
- 7. Funding the enhancement or upgrading of existing sports facilities or sports fields for certain municipalities. (THIS DOES NOT APPLY TO DEL RIO).
- 8. Funding transportation systems for tourists.
- 9. Signage directing tourists to sights and attractions that are visited frequently by hotel guests in the municipality.

II. Review Process

All applications must be delivered to the City Secretary's Office no later than end of business May 16, 2022.

An Internal Review Committee made up of City Staff and two City Councilmembers will review all acceptable applications from individuals, groups and organizations applying for the FY 2022-2023 HOT funding. An acceptable application is one that is complete and meets the deadline requirements.

Each group, with an acceptable application, will be scheduled for a date and time to present their request to the Committee. At the presentation, the Review Committee may ask questions and seek clarifications. A formal presentation is encouraged, however not required. Applicant(s) will be notified of either an in-person or virtual presentation.

After presentations are made, the Review Committee will make initial funding recommendations. Notification of the initial funding recommendations will be emailed to all applicants. Funding recommendations made to Council may differ from the amount requested in the application.

An applicant may submit a written appeal with the City Secretary's Office to the initial funding recommendation. The City Council will receive formal recommendations by the Internal Review Committee at a regularly scheduled Council meeting. All applications, supporting data, and written appeals will be included in the City Council's packets delivered 72 hours prior to the scheduled meeting. At that time, the City Council will make the final decision on the allocation of funds.

After Council approval, The City Secretary's Office will make arrangements to distribute and sign contracts with successful applicants where applicable.

Any organization that owes the City of Del Rio money or required reports will not receive funds until their debt is paid.
